This research paper elaborates the portraits of social justice in John Grisham's novel, *The Street Lawyer*, which are analyzed through sociological approach. The objectives of the research are to analyze the structural elements of the novel and to analyze the novel based on sociological perspective by identifying the relationship between the novel and the social background of American society at the end of 20th century.

This research belongs to qualitative research; the data of the research is the text of a novel entitled *The Street Lawyer*.
