The needs for progress encompass self-actualization. improvement in reality perception, acceptance of oneself, others, and nature, spontaneity, problem-focusing, detachment, and the urge for isolation, Autonomy, regardless of culture or setting Continued expressions of gratitude, Oneness with humanity, the oceanic sensation, and the mystic experience strong interpersonal ties, a democratic spirit, moral ends with ethical means, philosophical and inventive.

This research tells a lot about patriotism of Chris Kyle as NAVY Seal. Patriotism is included in political psychological approach. The research is qualitative research. The finding is the real-life drama behind the controversial war film American Sniper is being played out in court in a small Texas town, where for the shooting deaths of Chris Kyle and his companion Chad Littlefield at a nearby shooting range, Eddie Ray Routh is on trial. The film adaptation of Kyle's exploits, a former navy seal who is regarded as the worst killer in US military history, has sparked intense discussion over how the Iraq war, Kyle as a hero, and the treatment of wounded combat veterans after they return home are portrayed.

Fifth is a research written by Shenzhen (2015) entitled *American Sniper: The Autobiography of the Most Lethal Sniper in U.S. Military History.* Chris Kyle, a retired Navy SEAL sniper who has officially been verified to have killed more than 160 people in the Iraq War between 2003 and 2009, tells his compelling narrative in this book. It deals with the history of *American Sniper* and his appreciation. For a sniper, understanding mission objectives was important because he had to be careful to tell between insurgents and bystanders. "Make an unjustified shot and you could be charged with murder," he writes. The result of the study is Critics of American Sniper disagreed as well. The National Review, on the other side, thought that American Sniper is a fantastic movie that reached a great nation with a message it needed to hear. David Edelstein, writing in New York magazine, frankly termed it a scandalously blinkered propaganda picture and a Republican platform movie. While many people have been surprised by the movie's success, some people argue that it was not wholly unexpected.

Sixth is research is written by McVeigh (2013) entitled "The Devil" is no more: America's deadliest sniper was shot and killed at a range: Chris Kyle is the newest victim of gun violence in the US. Navy Seals claimed to have killed 255 people with gunfire. Trauma and his accident on his last day are the main topics of this study. Chris Kyle, a U.S. Navy Seal, had the most sniper kills in a career in American military history from 1999 to 2009. The study's findings are that he was known as "The Legend" by the American soldiers he defended throughout the Iraq War from rooftops and covert

locations. Kyle, who unfortunately died in 2013, writes frankly and honestly about the suffering of war, including the deaths of two close SEAL comrades. Taya, Kyle's wife, also speaks honestly about the toll that the war has taken on their family and on Chris. One of the best Great War memoirs ever written, Kyle's superb description of his special battlefield experiences is gripping and unforgettable.

Seventh is research is written by Rikawati (2019) with the title *The* Survival Strategies of The Main Character in The Film American Sniper by Clint Eastwood. The objectives of this study are to identify the types of survival techniques used by the main character in the movie American Sniper, to identify the means by which the main character manages to survive in the war zone as depicted in the movie American Sniper, and to identify the outcomes of the main character's use of survival techniques in the movie American Sniper. Both the descriptive approach and qualitative research were employed in this study. This study applies objective theory and a psychological methodology. According to study, Chris uses a variety of survival techniques. He eats to improve his energy and sleeps to preserve his stamina. He also feels safe from danger and the surroundings. The researcher had identified numerous areas, such as attire, language, body language, and other people who feature in this movie, to gather data. Story and plot were the two main elements in narrative analysis, and camera movements, costumes, settings, color schemes, noises, people, and environments were some of the technical elements in non-narrative. Ninth is research from Thompson, Westley (2019) with the title *American Sniper Good Portrayal of Heroism, Effect of War in Iraq*. The researcher focusses on the portrayal of heroic about Chris Kyle. The movie American Sniper does a fantastic job of highlighting both the good and bad aspects of war. On the one hand, combat is highly thrilling. The SEALs and Marines hunt down and eliminate opponents in American Sniper. War does have a terrible price. Some of the soldiers, who were among Kyle's closest friends, were injured or killed while serving in Iraq as a result of his leadership decisions. Even if it is fortunate enough to avoid bodily harm, war nonetheless entails a significant mental and emotional burden.

Tenth is research Fatimah, Ruliatul (2016) with the title American Sniper's portrayal of Chris Kyle as a hero: A study of popular literature. The goal of this study is to illustrate how heroes and heroic behavior are portrayed in the film American Sniper and to provide an explanation of why this is the case. In this study, the researcher draws on popular literature. Qualitative descriptive research is the research methodology. The data comes from two different sources: main data and secondary data. The data analysis method employed is content analysis. Twelfth is research from Subkhan, Muhammad Ilham (2018) *An Analysis of Idiomatic Expression Found on American Sniper Movie Writer*. Based on McCharty theory, this study examined idiomatic terms in the film American Sniper. The purpose of this study was to categorize the many kinds and connotations of idiomatic expressions used in the film American Sniper. Because the data were acquired from the conversations of the movie's transcript, the writer's research was planned as a descriptive qualitative study. The data were gathered through documentation. In order to analyze the data for this study, the steps from John W. Creswell (2007) were prepared and organized, then coding, and finally representing the data. According to the study's findings, 35 idiomatic idioms were present. Only 5 of the 8 idiomatic expression categories could be discovered in the film American Sniper.

Thirteenth is research from Yushinta, Pety (2016) Representation of The East Through the West's Eyes: Analysis of American Sniper Mo's Eyes: Analysis Of American Sniper Mo. This study investigates the ways the Iraqi cultures are represented through the eyes of westerners in the movie American Sniper by Clint Eastwood. Iraqi and other Middle Eastern civilizations are frequently interpreted with an implicit presumption that the west is superior and the east is inferior. The theoretical underpinning for this study is Orientalism by Edward Said (1978). The specific form that Western stereotyped perceptions of Eastern cultures have assumed is known as

"orientalism." As long as prejudices are retained and the other culture is perceived as alien and utterly different, intercultural dialogue becomes extremely difficult. The study finds that Iraq is represented as timelessness, exotic, degenerates, and constructs binary opposition. Based on an Orientalist perspective, those negative characteristics are considered as Orient stereotypes.

Fourteenth is research from Cannon, Taylor Margaret (2016) *Man'o War: Collisions of Masculinity and Patriotism in American Sniper*. This thesis examines the connection between dominating manhood and American military patriotism via Chris Kyle, the protagonist of the book, using the movie American Sniper as a case study. Kyle was well-known in the public because he is usually regarded as the deadliest sniper in American military history. However, due to potential exaggerations and misconceptions about his background that may have been included in the book, his renown was hotly contested in the mainstream media, especially after the release of his autobiography. This thesis claims that he is presented in American Sniper in a similar way and is shown as a man who fulfills current American conceptions of a true patriot and a "real" man.
