THE CONCEPT OF CHARACTER EDUCATION IN THE BOOK TADZKIROTUS SAMI'WAL MUTAKALIM BY IBNU JAMA'AH AND ITS RELEVANCE TO THE 2013 CURRICULUM

Abstrak

Bab ketiga, adab seorang murid terhadap dirinya sendiri, gurunya, teman-temannya, dan pelajarannya. Bab keempat, adab berinteraksi dengan buku. Dan bab lima, adab-adab tinggal di madrasah. Tujuan dari penelitian ini adalah untuk menjelaskan pendidikan karakter dalam kitab Tadzkirotus Saami' wal Mutakallim karya Ibnu Jama'ah dan relevansinya dalam kurikulum 2013, dengan mengambilnya sebagai subjek penelitian dan menggunakan metode kualitatif. Dalam pengumpulan informasi dan penulisan, penulis menelaah berbagai sumber yang dijadikan referensi, yaitu pendidikan karakter Islam dan kurikulum. Abstract

The work of al-Imam al-Qadhi Badruddin Ibn Jamaah is more comprehensive and has a scope that contains five topics of discussion about manners that have not been found in other books of manners. Chapter one, the virtues of knowledge and its experts. Chapter two, the manners of a teacher towards himself, his students, and the manners of teaching. Chapter three, the manners of the student towards himself, his teacher, his friends, and his studies. Chapter four, the manners of interacting with books. And chapter five, the manners of staying in the madrasa. The purpose of this study is to explain character education in the book of Tadzkirotus Saami' wal Mutakallim by Ibn Jama'ah and its relevance in the 2013 curriculum, by taking it as a research subject and using qualitative methods. In collecting information and writing, the author examines various sources used as references, namely Islamic character education and curriculum. The results of this study indicate that character education in the book of Tadzkirotus Saami' wal Mutakallim by Ibn Jama'ah is in accordance with the 2013 curriculum which is based on student skills by providing great support for character development.

1. INTRODUCTION

The reference that can be used to develop character values in this case is the book Tadzkirotus Saami' wal Mutakallim. The book was written by Muhammad bin Ibrahim bin Sa'dillah bin Jama'ah or known to knowledge seekers as Ibn Jama'ah. This book can be a reference book for character development because the curriculum has proven successful in improving the morals, worship and aqidah of many people and the author has also been recommended by many scholars. Zarnuji with the 2013 curriculum is to accept (sorting knowledge, teachers and friends), implement (intensity, continuity, and enthusiasm), appreciate (glorify knowledge and Ulama), appreciate (learning procedures), and practice (tawakkal and wara when learning). This means that the character values in the book are still relevant especially with the curriculum from the government. That is the 2013 curriculum.

2. METODE

The author uses a type of research in the form of library research, namely by using books and other written works to collect information related to research and make it a research subject and using qualitative methods. From the previous explanation, it is concluded that activities related to collecting library materials, storing and criticizing research materials, and processing them are called library research. This research uses a research approach in the form of a philosophical approach and a social science approach. The philosophical approach is the study of the educational process based on the values of Islamic teachings according to the concepts of truth, knowledge and wisdom. In this research, the philosophical approach is achieved by extracting information from the book of Tadzkiratus Saami' wal Mutakallim, which is based on the Qur'an and Sunnah, to take good character values and integrate them into the school curriculum, namely the 2013 Curriculum. The social science approach in this research aims to understand how the implementation of this knowledge in daily life. In this research, the sources of information used are books, selected websites and journals related to the research case. The data sources used by the author in this study are Primary and secondary data. The primary data is the book Tadzkirotus Saami' wal Mutakallim by Ibn Jama'ah as main source and for secondary data is complements the main source of research.
