CHAPTER I

INTRODUCTION

A. BACKGROUND OF THE STUDY

Literature is about presentation of human life. Literary work is reflection of the authors's imagination that shows the phenomenon in their life. It means when the authors make their literary works, there is an expression of problem from the authors' point of view. Literary work has relation with human life, it is appropriate to use psychology as an approach in understanding human being from psychological point of view. An understanding literary work also has connection with human being. There are a few issues related to the connection with our fellow human beings. One of wrong attitude is bullying.

According to Olweus (1993) "Bullying is a negative actions on the part of one or more other students. Olweus (1993) also added that bullying is evident when it is divicult for students who are being bullied to defend themselves. This is supported by a statement of Craig and Pepler (1998), which defines bullying as "negative actions physically or verbally that shows hostility, causing distress to the victim, usually within a certain times and involves a power differential between the subject and the victim."

Based on the experts opinion above it can be concluded that bullying is a negative action that causes trauma to the victim, the trauma can be either physical such as bruises and wounds on the body while psychological for example stress, not confident and the other.

The author of *Bound* novel, Okky, was born on October 30, 1984 in Magetan, East Java, Indonesia. She graduated from Gadjah Mada University's International Relations Department in 2005 with Bachelor Degree in Political Science. She has chosen to become a

journalist and writer ever since her graduation. In 2012, she took sociology for her Master's degree from the University of Indonesia, and graduated in July 2014 with a thesis on Genealogy of Indonesian Novels: Capitalism, Islam and Critical Literature. Okky's novels consistently voice human rights and freedom, and are always against any form of repression. Okky is a realist, with all of her novels attempting to portray the face of Indonesia. While she tells mostly about Indonesia and its people, the issues she carries in her novels showcase basic and universal human kind's problems.

Okky's first novel, *Entrok* (2010) tells about a woman that can survive althought for that time Indosians live under dictatorship. Her second novel 86 (2011) vividly describes the prevalent corruption within the country and especially among its civil servants the novel was short listed as top five in the Khatulistiwa Literary Award in 2011. Her third novel *Maryam* (2012) which describes how Ahmad is violently thrown way from their own home and homeland without any protection from the government won the 2012 Khatulistiwa Literary Award. The novel has been translated into English under the title of *The Outcast. Pasung Jiwa* is her latest novel, released in May 2013. It addresses individual striggle to break free from his or her own individual limitation as well as the containment of norm, tradition, religion, state, and econommic dominance of the few rich. The novel was shortlisted by the Khatulistiwa Literary Award in 2013. *Pasung Jiwa* has also been translated into English under the title of *Bound* in July 2013.

Bound is one of novels written by Okky Madasari which describes the real life. The Bound novel tells about Sasana. Sasana's father was Lawyer whereas his mother was a surgeon and he has a younger sister her name is Melati. Sasana's parent has an obsession to make their son become a good pianist. They present piano music when Sasana was still in

the womb. Later when Sasana was born, they forced Sasana to become a pianist. He obeys his parents willingness to play the piano and choose to be a bright child, for the parents as well, not for himself. Starting from that time Sasana can not express his opinion. When Sasana enjoys *Dangdut* music accidentally. He feels this is what he was looking for, freedom and sway. For him *Dangdut* is fun, because it can make him want to dance. But his parent doesn't like this. Sasana's parent was angry and never let Sasana hear that music anymore.

After finishing middle school, Sasana studied in hight school for boys. His parents had choosen it, without asking Sasana where he wanted to study. But apparently his parent decision to take a place Sasana into Senior hight school for boys is wrong. After few months Sasana got bullying from his senior at school. Sasana taken to the toilet at the back of school. The toilet was a secluded spot and far from where the other students usually gather. There Sasana gets beatings in the chest, and kicks to his body. His senior forceD Sasana to join with their gang. Sasana approved it and he should give all of his pocket money to Dark Gang members everyday. By this incident Sasana became hate boys and himself.

Not only in high school Sasana got unpleasant treatment. Sasana moved to Malang to college. Sasana who hates boys turned into a woman because he met Cak Jek. Sasana changed his name become Sasa. Sasa and Cak jek become a busker. Someday Sasa and Cak Jek with his friends demonstrate to fight for the fate of Cak Man's daughter. But when the demonstration Sasa was arrested by the soldiers. Then Sasa brought to the jail. There Sasa got inhuman treatment by the soldiers. Sasana was beaten, humiliated, reviled, and raped by army soldiers. There his hatred towards men increasingly deep.

For the reasons, the researcher is interested with Sasana as a major character in Bound novel. Sasana has bad experience when he was young and it can be influenced to his future. Everything that happens in childhood likely will have impact on the physical or mental development. Especially it is Negative treatment. Bullying is very close with daily life. Surrounding, bullying in everywhere, toward someone or groups. This phenomenon reputed common placed and have not serious impact for one's life. But actually we were created to respect every creature of God.

Based on the explanation above the researcher wants to analyze bullying which is reflected in *Bound* novel by using psychological approach. Therefore the researcher conducts the research entitled BULLYING REFLECTED IN OKKY MADASARI'S BOUND (2013) NOVEL: A PSYCHOANALYTIC ANALYSIS.
