CHAPTER I

INTRODUCTION

A. Background Of Study

While acting in the 1962 movie War Hunt he became friendly with Robert Redford, who was making his screen debut. When Pollack decided to move behind the camera, Redford was eager to work with him. They have since collaborated on seven films: This Property Is Condemned (1966), Jeremiah Johnson (1972), The Way We Were (1973), Three Days of the Condor (1975), The Electric Horseman (1979), Out of Africa (1985), and Havana (1990). Out of Africa in fact, won Pollack his first Academic Award as Best Director.

Pollack was also nominated for the wrenching Depression-era drama They Shoot Horses, Don't They? (1969) And the crackerjack comedy Tootsie (1982), which forced him back in front of the camera when Dustin Hoffman insisted that Pollack play his agent in the movie, which he did, delightfully. In 1992 he appeared in The Player contributed the funniest scene to Death Becomes Her as Meryl Steep's addled doctor, and delivered a superb seriocomic performance as Judy Davis' errant husband in Woody Allen's Husbands and Wives.

In recent years Pollack has devoted more time to producing than directing, numbering among his credits (as producer or executive producer) Honeysuckle Rose (1980), Songwriter (1984), Bright Lights, Big City (1988), Major League, The Fabulous Baker Boys (both 1989), Presumed Innocent, White Palace (both 1990), Dead Again, King Ralph (both 1991), Fischer and Flesh and Bone (both 1993). He also executive produced the high-profile cable TV series "Fallen Angels" in 1993, and then returned to the director's chair for The Firm (1993) and Sabrina (1995). John Grisham is best-selling novelist of the 90's. He was born on 8, 1955 in Jonesboro, Arkansas. Realizing he did not have the right stuff for a pro career, he shifted gears and majored in accounting at Mississippi State University. After graduating from law school at Ole Miss in 1981, he went on to practice law for nearly a decade in Southaven, specializing in criminal defense and personal injury litigation n. He explored first novel when he overheard the harrowing testimony of a twelve-year-old rape victim. After that, he becomes an American novelist that has written a lot of novel. *The Firm* is one of his best-selling novels, with more than 7 million copies in print, was on The New York Times best-seller list for 18 consecutive weeks. The Grisham's works are The Firm, The Brethren, A Time to Kill, The Pelican

Brief, The Client, The Chamber, The Runaway Jury, The Rainmaker, The Partner, The Street Lawyer and King of Torts.

The actor in this novel is Tom Cruise (Thomas Cruise) he is the famous actor in a Hollywood one day in the not too distant future he would be considered one of the top 100 movie stars of all time, he would have probably grinned and told you that his ambition was to become a priest. Nonetheless, this sensitive, deeply religious youngster who was born in 1962 in Syracuse, New York, was destined to become Tom Cruise, one of the highest paid and most sought after actors in screen history. The only son (among four children) of nomadic parents young Tom spent his boyhood eternally on the move and by the time he was 14 he had attended 15 different schools in the US and Canada. He finally settled in Glen Ridge, New Jersey, with his mother and her new husband. While in high school, he developed an interest in acting and abandoned his plans of becoming a priest, dropped out of school, and at age 18 headed for New York and a possible acting career First actor in history to star in five consecutive novel that grossed \$100 million in the USA: A Few Good Men (1992), The Firm (1993), Interview with the Vampire: The Vampire Chronicles (1994), Mission: Impossible (1996), Jerry Maguire (1996). For 1988, he became the first actor to have the distinction of starring in both the year's Oscar winner for Best Picture, Rain Man (1988).

This story is very interesting to analyzed, reflected in the Firm novel. It is the story of a hotshot young attorney lured to an apparently law firm that was not it appeared. Mitch McDeere the main character of this novel is

described as a lawyer newly graduated from Harvard College, who seek success. He dreams of being a successful lawyer by joining a law firm, name Bendini and Lambert.
