missing from their home. As the days and weeks go by, the Collins case becomes the object of a campaign by Pastor Gustav Briegleb (John Malkovich) who rails against the incompetence and corruption of the Los Angeles police Department. Soon, the police arrive with the news that they have found her boy but when the lad is turned over to her, she realizes that the police have returned a stranger to her in an attempt to ring an end to the public complaints about their handling of her case.
