CHAPTER I

INTRODUCTION

A. Background of the study

Political justice refers to the use of the judicial process for the purpose of gaining (or upholding or enlarging) or limiting (or destroying) political power or influence. It may accompany or confirm political or military action, or it may be a substitute for such action. Political justice usually involves the courts, which may be invoked either by public officials or, in those societies which permit open competition for political power, by private individuals. The party invoking the judicial arm must present its demands in a form susceptible of legal determination. This party's allegations in regard to facts must be open to incrimination and proof under the specific legal system involved. These allegations may relate to intrinsically political acts or to common crimes in which the criminal is charged with political motivation, for example, bank robbery to finance revolutionary activity. Those bringing the case may reap propaganda benefits from the political stature of a person implicated in offenses

of a nonpolitical and even technical nature, for example, violation of foreign exchange regulations.

The political and intellectual climate deteriorated in the interwar period. The concept of the independent and unified national state was challenged by technological changes, by the increasing intransigence of domestic political deviations, and by external threats to the autonomy of the nationstate. Furthermore, a number of states were reorganized on totalitarian lines far more restrictive than had been the case with old-fashioned autocracies. Consequently, twentieth-century statutes have tended to narrow the perimeters of permitted political activities, facilitating the prevention or detection by the state apparatus of even the most incipient stages of hostile organization or propaganda. Internal and external dangers have given rise to concepts such as "demoralization" of the army or nation and "danger to the existence or independence" of the state.

True justice is a science fiction novel published in 2000. Thus emerged a criminal acts, violence, molestation, sexual harassment, and sexual misconduct. It all arises from a family economic limitations and his lack of parental supervision of the child. If a child is getting lessattention and supervision of a parent would be fatal. Robert K. Tanenbaum is an American trial attorney, novelist, and former mayor of Beverly Hills, California and one of the country's most successful trial lawyers -- he has never lost a felony case. He has been Bureau Chief of the New York Criminal Courts, ran the Homicide Bureau for the New York District Attorney's Office, and served as Deputy Chief Counsel to the Congressional Committee investigations into the assassinations of President John F. Kennedy and the Reverend Dr. Martin Luther King Jr. He has taught Advanced Criminal Procedure at his alma mater, the University of California at Berkeley, Boalt Hall School of Law. His previous works include the novels Fatal Conceit, Bad Faith, Tragic, Outrage, Betrayed, Capture, and Escape; and three true-crime books, Echoes of My Soul, The Piano Teacher: The True Story of a Psychotic Killer, and Badge of the Assassin.

The Early life and education of Robert K. Tanenbaum, born in Brooklyn, New York, attended the University of California, Berkeley on a basketball scholarship where he earned a B.A. He received his J.D. from Boalt Hall School of Law at the University of California, Berkeley. It was under the leadership of District Attorney Frank Hogan where Tanenbaum learned about trial preparedness and presenting evidence to a jury as an Assistant New York County District Attorney in Manhattan. Later, Tanenbaum became head of the Homicide Bureau, served as Chief of the Criminal Courts, and was in charge of the D.A.'s legal staff training program. During his time in the D.A.'s office, Robert K. Tanenbaum never lost a felony case. After his tenure in Manhattan's D.A.'s

office, Robert K. Tanenbaum served as Deputy Chief Counsel for the House Select Committee on Assassinations to investigate the John F. Kennedy assassination and the Martin Luther King, Jr. assassination. In 1988 he appeared in the documentary "The Men Who Killed Kennedy

In private practice, notably, he was a special prosecution consultant on the Hillside Strangler case in Los Angeles; defended Amy Grossberg in her sensationalized baby death case; and represented eight black plaintiffs in a significant racial profiling case. He taught Advanced Criminal Procedure for four years at Boalt Hall School of Law at the University of California, Berkeley. He conducts continuing legal education seminars for practicing lawyers in California, New York and Pennsylvania. He remains a member of the State Bars of New York, Pennsylvania and California.

The Political career of Robert K. Tanenbaum served two terms as Mayor of Beverly Hills and was a City Council Member for eight years. He also ran D.A. Frank Hogan's re-election campaign for District Attorney in 1973 and the Literary career of Robert K. Tanenbaum is the author of 28 books; 26 novels and 3 nonfiction works. The Piano Teacher is the story of a psychotic killer. Badge of the Assassin recalls the true account of Tanenbaum's investigation and trial of self-proclaimed members of the Black Liberation Army who assassinated two NYPD police officers, Waverly Jones and Joseph Piagentini. It was later adapted into a movie titled Badge of the Assassin, starring James Woods as Tanenbaum. Tanenbaum's signature work, Echoes of My Soul was published in May 2013 by Kensington Books and was named 'Pick of the Week' by Publisher's Weekly in its April 22, 2013 edition. It is the true story of one of the most intense manhunts in police history—and of the young District Attorney who exonerated the unjustly accused, brought the killer/ rapist to justice and forever reformed law enforcement practices, paving the way for the Miranda Decision.

His latest novel, Tragic, is a murder mystery that focuses on the murderous effects of weak character and unbridled ambition intertwined with shocking tempestuous deception, was published by Simon and Schuster Gallery Books on

August 13, 2013.
