CHAPTER I

INTRODUCTION

A. Background of the Study

Social class is a phenomenon that occurs in society. Social class causes differences in groups within a society, this is due to the level of social class which makes the rich people as the upper class and the poor people as the lower class. Nowadays, many people wrongly use their social class status to have an arbitrary attitude to other class groups who are not at the same level. Jane Austen is one of the famous novelists who came from England. Born in Steventon, Hampshire, England in 1775, Jane Austen has produced six works in the form of novels that are so extraordinary. Jane focused on her passion for exploring a woman's dependency in a marriage that they do only to pursue and get a high social class position to ensure their survival remains well-off from an economic standpoint and is not looked down on because of the social class they get from a man. Jane Austen often includes a critique and commentary on British nobility in the early nineteenth century in each of her works.

Pride and Prejudice is one of the best works of Jane Austen that lifts a love story in British society in the early nineteenth century. In her works, Jane Austen provides exploration relating to the way of life of British society amid differences in social classes. In her novel, Austen

After finishing his business in London, Bingley returned to Netherfield Park with her siblings and best friend, Mr. Darcy. Mr. Bingley and his entourage went to a party held in the city of Meryton. It was there that finally Mr. Bennet to introduce his daughters to Mr. Bingley happened. Unexpectedly it turns out that Mr. Bingley was interested in Mr. Bennet's daughter named Jane Bennet. Mr. Darcy who is a friend of Mr. Bingley turned out to feel a sense of Elizabeth Bennet. Mr. Darcy's attitude Cold and slightly arrogant made Elizabeth uninterested in Mr. Darcy.

The love story of two couples who have different social classes certainly does not run easily. Mr. Bingley and his entourage were forced to leave Netherfield and return to London, there was no clear reason for the decision they had made, but that made relationship Mr. Bingley and Jane Bennet ended because of Mr. Bingley's youngest sister named Caroline

sent a letter to Jane stating that Mr. Bingley likes Mrs. Georgina Darcy sister of Mr. Darcy and that is unknown to Mr. Bingley. The same is true of the love story of Mr. Bingley and Jane Bennet, Mr. Darcy was forced to end his relationship with Elizabeth Bennet because Mr. Darcy has been forced to marry the daughter of Lady Catherine named Miss Catherine de Bourgh. Even so, the love story of the two couples ended happily. Mr. Bingley finally proposed to Jane Bennet accompanied by her best friend, Mr. Darcy. After Mr. Bingley proposed to Jane Bennet shortly afterward Mr. Darcy also ventured to apply for Elizabeth Bennet and Elizabeth Bennet accepted the proposal Mr. Darcy is happy. End of the story, Mr. Bingley was married to Jane as well as Mr. Darcy is married to Elizabeth and they live happily together in the residence of Mr. Darcy at Pemberly House.

Pride and Prejudice have become a very famous novel start from the first publication to the present. So, that is why Pride and Prejudice have been read by many people in this world. For that reasons certainly, many people who provide comments or responses about Pride and Prejudice by Jane Austen. Here are some responses from readers of Pride and Prejudice novels.
