Abstrak

1. INTRODUCTION

Other researchers revealed in the workplace bullying survey that took place at Staffordshire University in 1994 (Rayner, C., 1997). Other researchers discussed the impact of bullying in Stephen King's novel "Carrie" (Sitorus, A. M., 2018).

The research of previous studies above shows that they are classified based on data sources, namely fields and literary works relevant to the topic of this research. In this study, researchers used a psychological perspective that focuses on the mental health impacts of victims of bullying. The novelty in this research is to describe the indicators of bullying, to describe the bullying in the novel, and the reason why the writer raised the bullying in the novel.

2. METHOD

Bullying is a phenomenon from various kinds of groups that can directly affect all elements of society each year. According to Sanders, C. E. (2004) states that the explicit definition of bullying based on a unifying theory that includes ecological and evolutionary contexts states that bullying includes aggressive behavior that leads to certain goals where the action can harm other individuals in the context of a power gap. We recommend that bullying should be based on the assessment of these three elements of bullying. The three elements of bullying include goaldirection, power gap, and danger. Bullying is a violent act that is carried out continuously and there is no balance between the forces between the parties. This study used the hermeneutic data analysis method described by (Michael & Williams, 2002). In this method, there are six techniques that can be used to analyze data. While the data analysis process, the authors used the qualitative method described by (Miles & Huberman, 1994). In this method, there are three techniques, namely data reduction, data display, and drawing conclusions. The purpose of this study is to describe the mental health impacts of victims of bullying in a novel entitled "The Reluctant

Journal" which was first published in 2012. This research uses the psychological theory by Wellek and Warren to examine the moral messages in this novel.

3. FINDINGS AND DISCUSSION

3.1 Indicators of Bullying

3.1.1 Insulting Others

3.4 Discussion

This study is useful to complement previous studies because this study is different from other research which uses data in the form of the novel *TheReluctant Journal*.

This novel is a reflection of the author's concern over the increase in bullying cases in several countries. Based on the ASCB science page, there are five countries with the highest cases of bullying in the world, including: (1) Portugal is in the first position with the highest number of bullying cases in Europe, especially in the world; (2) Britain is in the second position with the highest number of bullying cases in the world because about 29 percent of schools in England have bullying cases almost every week; (3) Estonia is in the second position with the highest number of bullying cases in the world because bullying cases do not only occur in the school environment but these cases also often occur in the work environment; (4) Russia is in the second position with the highest number of bullying cases in the world because nearly 30 percent of school children in Russia have received bullying from their schoolmates; and (5) Austria is in the second position with the highest number of bullying cases in the world because bullying cases often occur in schools and academies.

The author provides a moral message to readers for mutual tolerance between humans, open-mindedness, sympathy, and empathy. Of the four things, it is something that is very important in social life. To achieve these four things, children should be taught from an early age the meaning of these four things starting from the smallest things.

4. CLOSING
