#### **CHAPTER V**

### **CONCLUSION, IMPLICATION, AND SUGGESTIONS**

In this chapter, the researcher presents the results of the research analysis including conclusions, implications, and suggestions.

### A. Conclusion

Based on the data analysis and findings in the previous chapter, it can be concluded that:

### 1. The Types of Register

Based on the data analysis and discussion of findings in the previous chapter, of the five types of registers proposed by Martin Joos, there are two types of register found by the researcher in this research paper, namely the consultative register (30%) and the casual register (70%). Based on the percentage, it can be concluded that the highest frequency data on the types of register in this study is the casual register which is 70%.

### 2. The Meaning Types of Register

Based on data analysis and discussion of findings in the previous chapter, from the seven meaning types of register proposed by Geoffrey Leech, the researcher found two meaning types of registers in this research paper. The meaning types of register found are affective meaning (20%) and social meaning (80%). Based on the percentage, the highest frequency data on the meaning types of register in this study is the social meaning which is 80%.

# **B.** Implication

Based on the discussion in previous chapters, the results of this study present theoretical and practical implications, as follows:

### **1. Theoretical Implication**
