(Since the 18th century, the term "novella", or "novelle" in German, has been used in English and other European languages

to describe a short story or a short novel.). The Tale of Genji by Murasaki Shikibu (1010) has been described as the first novel in the world. The spread of printed books in China led to the emergence of classical Chinese novels by the Ming dynasty (1368-1644). Parallel European developments occurred after the invention of the printing press. Miguel de Cervantes, author of Don Quixote (the first part of which was published in 1605), is often cited as the first significant European novelist in the modern era. [2] Ian Watt, in The Rise of the Novel (1957), suggests that modern novels were born at the beginning of the 18th century.

The Lightning Thief is an American fantasy-adventure novel based on Greek mythology, the first young adult novel written by Rick Riordan in the Percy Jackson & the Olympians series. The manuscript was sold in an auction to Miramax Books, an imprint of Hyperion Books for Children and thus Disney Publishing (succeeded by the Disney Hyperion imprint).

The novel charts the adventures of modern-day twelve-year-old Percy Jackson as he discovers he is a demigod, the son of a mortal woman and the Greek god Poseidon. Percy and his friends Annabeth Chase and Grover Underwood go on a quest to find Zeus's stolen lightning bolt and prevent a war between the gods Zeus, Poseidon, and Hades.

Rick Riordan is the New York Times bestselling author of over twenty novels for young readers, including the Percy Jackson series, the Kane Chronicles, the Magnus Chase series and the Trials of Apollo. He is also the author of the multi-award-winning Tres Navarre mystery series for adults. For fifteen years, Rick taught English and history at public and private middle schools in the San Francisco Bay Area and in Texas. While teaching in San Antonio, Saint Mary's Hall honored him with the school's first Master Teacher Award. While teaching full time, Riordan began writing mystery novels for grownups. His Tres Navarre series went on to win the top three national awards in the mystery genre – the Edgar, the Anthony and the Shamus. Riordan turned to children's fiction when he started The Lightning Thief as a bedtime story for his oldest son. Today, eighty-six million copies of his books are in print in the United States, and rights have been sold into more than 37 countries. Rick Riordan now writes full-time. He lives in Boston with his wife and two sons. The Lightning Thief was published in July 2005. The

book has sold over 1.2 million copies in the subsequent four years, appearing on The New York Times children's Best Seller list and being listed as one of the Young Adult Library Services Association's Best Books for Young Adults, among other awards. It was adapted into a film named Percy Jackson & the Olympians: The Lightning Thief released in the United States on February 12, 2010. This novel is followed by The Sea of Monsters and spawned two sequel series and the extended universe of the Camp Half-Blood chronicles. The Lightning Thief (Percy Jackson and the Olympians) in 2010, The Titans Curse's (books 3) in 2008, and The Lighting Thief in 2006.
