


ABSTRAK

The second finding is that the swear words have a functions to show anger, to show friendliness, annoyance, to show happiness, solidarity, insult and to show aggression. From the second finding, it can be conclude that swear words still has a function to express the speaker anger rather than to express happiness or solidarity.
