THE ANALYSIS OF WOMEN'S PRIVILEGES IN THE "ANGELS AND DEMONS" MOVIE USING THE THEORY OF FEMINISM APPROACH

- **1.2.4 Psychoanalytic and Gender Feminism** delve into the psychological and cultural construction of gender. This perspective examines how unconscious processes and early childhood experiences shape gender identity and roles. Psychoanalytic feminists explore the ways in which patriarchal culture influences the formation of gendered identities, often focusing on the internalization of gender norms and the psychological impact of gendered socialization (Zhou et al., 2023).
- **1.2.5 Existentialist Feminism** emphasizes individual autonomy and the importance of personal choice in overcoming gender oppression. This perspective argues that women must assert their agency and reject societal expectations that limit their potential. Existentialist feminists focus on the need for women to define themselves rather than being defined by traditional gender roles imposed by society (Irshad & Yasmin, 2022).

- **1.2.7 Multicultural and Global Feminism** highlight the importance of considering race, ethnicity, and cultural context in feminist analysis. These perspectives recognize that women's experiences are shaped by multiple intersecting identities, including race, class, and nationality. Multicultural and global feminists advocate for an intersectional approach to gender analysis that takes into account the different ways in which various forms of oppression intersect and reinforce each other (Irshad & Yasmin, 2022).
- **1.2.8 Ecofeminism** connects the exploitation of women with the degradation of the environment, arguing that both are products of patriarchal systems that prioritize domination and control. Key moments, such as her introduction at CERN and her decisive leadership during the laboratory explosion, underscore her privileged status within a male-dominated field. These scenes showcase how the film positions women with equal opportunities and respect as men. Vittoria's ability to assert her expertise, take decisive actions, and lead effectively in a crisis highlights the film's portrayal of women as equally competent and influential in professional roles. This representation aligns with feminist principles by demonstrating that women can hold authoritative positions and exercise significant impact in their professional environments, thereby challenging traditional gender disparities.

(2) Reflection of Women's Privileges Through Feminist Analysis: This involves examining how Vittoria's character embodies women's privileges through her professional achievements and emotional resilience. Her partnership with Robert Langdon reflects mutual respect and collaboration, portraying her as an equal in their professional relationship. Additionally, her confrontations with church officials highlight her resistance to patriarchal authority and assertive knowledge, reinforcing feminist ideals. These interactions illustrate the film's alignment with feminist themes by portraying Vittoria as a capable and empowered figure who navigates and challenges patriarchal structures. Her character's ability to manage complex social hierarchies and assert her expertise in a maledominated context serves as a testament to her privileged status, supporting themes of gender equality and resistance against traditional gender norms.

3.2 Discussions

The analysis of Vittoria Vetra's character in "Angels and Demons" offers profound insights into the film's alignment with and challenges to various feminist frameworks. This examination explores her portrayal through the lenses of second-wave, third-wave, and radical feminism, highlighting the cultural and social implications and offering recommendations for future media representations.

Vittoria Vetra's character strongly aligns with the principles of second-wave feminism, which emphasizes gender equality in professional settings and the dismantling of systemic barriers that prevent women from reaching their full potential. Her role as a leading scientist in antimatter research is a clear representation of this feminist ideology. A pivotal moment in the film, where she takes decisive action during a laboratory explosion (Minute: 0:25:00), demonstrates her professional competence and leadership. Her command, "Everyone get out now! It's going to blow!" is not just a response to an emergency but a testament to her ability to lead under pressure. This portrayal reflects second-wave feminism's focus on recognizing women's capabilities in traditionally male-dominated professions.

Third-wave feminism, which addresses the diverse and intersectional experiences of women, is also reflected in Vittoria's character. Her emotional depth, particularly in response to her father's death (Minute: 0:18:00), adds a layer of complexity to her character. She expresses both grief and determination to continue her father's work, stating, "He was everything to me. This work, it's his legacy. I have to see it through." This moment captures the intersection of her personal and professional identities, aligning with intersectional feminist theories that emphasize the multifaceted nature of women's experiences. The film thus portrays her as a character whose strength is derived from both her intellectual prowess and emotional resilience, embodying the principles of third-wave feminism.

Moreover, the film challenges patriarchal structures, a central tenet of radical feminism. This is evident in Vittoria's confrontations with church officials, where she asserts her scientific knowledge against patriarchal authority (Minute: 1:30:00). Her statement, "With all due respect, Father, this isn't just about faith. It's about science, and I know what I'm talking about," is a direct challenge to the traditional power dynamics that radical feminism seeks to dismantle. Vittoria's refusal to be marginalized highlights the film's engagement with feminist discourse on the need to confront and challenge patriarchal authority.

The cultural and social context of the film is also significant. Vittoria's role as a leading scientist reflects broader societal changes advocating for gender equality in traditionally male-dominated fields, particularly in STEM. Her partnership with Robert Langdon, characterized by mutual respect and collaboration (Minute: 0:20:00), further challenges traditional gender norms. However, the film also illustrates the persistent barriers women face in navigating patriarchal structures, as seen in Vittoria's interactions with church officials. This tension between progressive ideals and entrenched traditional power dynamics reflects the complex reality of women's experiences in contemporary society, demonstrating both the advancements and ongoing challenges in gender equality.

This research contributes to feminist discourse by offering a nuanced analysis of how mainstream films represent women. While Vittoria's character is portrayed with depth and complexity, there is a tendency in the film to position female characters in supporting roles to male protagonists. This insight underscores the need for media creators to develop narratives that place women at the forefront, showcasing them as leaders and primary agents of change. The film's depiction of Vittoria's resistance to patriarchal structures is a powerful example of how media can address and challenge traditional power dynamics, contributing to the broader feminist discourse on empowerment and equality.

To improve the representation of women in media, filmmakers and media creators should consider several recommendations. First, it is essential to highlight professional competence by depicting women in diverse roles that emphasize their expertise and contributions. Second, ensuring equal partnerships in narratives where women and men collaborate as equals is crucial. This approach not only challenges traditional gender norms but also promotes gender equality. Third, filmmakers should incorporate storylines that allow female characters to challenge and navigate traditional power dynamics, reflecting the principles of radical feminism. Fourth, it is important to emphasize the emotional depth of female characters, showcasing the multifaceted nature of their experiences. Finally, promoting diverse representations that reflect the intersectionality of women's experiences is essential. This includes ensuring that portrayals in media reflect the diverse identities and challenges faced by women in different cultural and social contexts.

In conclusion, the portrayal of Vittoria Vetra in "Angels and Demons" offers valuable insights into feminist theories and the representation of women in media. While the film makes positive strides in portraying women as competent and equal partners, there is still a need for more narratives that place women at the center of the story. By continuing to challenge traditional gender norms and promote diverse representations, filmmakers can contribute to a more balanced and empowering portrayal of women in media.

4. CONCLUSION

The study concludes that 'Angels & Demons' offers a nuanced depiction of women's privileges, blending elements of empowerment with traditional gender stereotypes. The film's portrayal of women reflects broader cultural tensions between the persistence of patriarchal norms and the push for gender equality.
